DETAILED NOTICE INVITING TENDER (NIT)

JSW Energy (Barmer) Limited (JSWBL) (Formerly: Raj WestPower Limited), a 100% subsidiary of JSW Energy Limited (JSWEL), hereinafter referred to as "the Company", The Company wishes to invite Bids for OPERATION AND MAINTENANCE OF CROSS COUNTRY PUMPHOUSES AND ITS PIPELINE (of length 180kms) FOR 8 X 135 MW LIGNITE BASED THERMAL POWER PLANT AT BARMER, RAJASTHAN

Interested Applicants should meet the qualification criteria as under:

Technical Criteria Qualification:

The bidder should have:

Ia) Operation and Maintenance of cross country pipeline and pump house of minimum length of 100 km and having minimum capacity of 2000 M3/Hour.

AND

Ib) Electrical competent certificate from electrical inspector issued by Rajasthan government.

OR

IIa) Having executed civil project of roads, pipelines in the Barmer, Jaisalmer area for similar type of work and well aware of local conditions

AND

IIb) Electrical competent certificate from electrical inspector issued by Rajasthan government.

Financial Criteria:

The applicant must meet the following financial requirements:

A Turnover:

The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of bid opening, shall not be less than Rs.1.00 Crore (Rupees One Crore only).

B Nature of Applicants: Joint Venture / Consortium Applicants: Allowed.

Bid documents will be issued to all the parties on their request for issue of bid documents without prima-facie examination of their qualification status. **However, issue of bid documents shall not mean that bidders are considered qualified.** Interested Applicants may obtain the Bid Documents from the office of undersigned on submission of formal request along with the specified fee. The request must clearly state "Request for Bid Document for OPERATION AND MAINTENANCE OF CROSS COUNTRY PUMPHOUSES AND ITS PIPELINE (of length 180kms) FOR 8 X 135 MW LIGNITE BASED THERMAL POWER PLANT AT BARMER, RAJASTHAN" The documents shall be available for a non-refundable fee (inclusive of GST) of Rs. 1,000/-. The non-refundable fee is to be paid through RTGS against below mentioned account & RTGS details (UTR, Proof of Payment) are to be given for purchase of tender documents.

Applicants may collect the documents (soft version / hard copy) in person or through an authorised agent on all working days within 10 (Ten) days from the date of NIT in the Newspaper between 10:00 Hrs. to 17:00 Hrs. If requested, Company shall dispatch the Document by registered mail/courier, but under no circumstances the Company will be held responsible for late delivery or loss of the documents so mailed.

1) Contract period:

The period of the contract will be 12 months from the date of award of contract. This contract can be extended for another 2 years on year to year (YOY) basis @ JSWBL discretion.

2) Site Visit: Bidders, in their own interest, should inspect and examine the site and its surroundings and satisfy themselves, before submitting their tender, in respect of the site conditions. The last date for site visit shall be the 10th day from the date of NIT in the newspaper between 10.00 Hrs. to 17.00 Hrs. We are closed on SUNDAYS.

3) Pre-Bid meeting open to all the Bidders will be held on 17th day from the date of NIT in the newspaper at 10:00 Hrs at JSWBL, Barmer, Rajasthan, wherein they shall be given an opportunity to obtain clarifications, if any, regarding the work and Bid conditions. The queries in this regard should be given in advance within 15th

days from the date of NIT in the newspaper upto 12.00 hrs in writing.

4A) Sealed Bids shall be submitted in single stage –

- a. Envelope -I : Bid Security
- b. Envelope II : Qualification particulars & Technical Bid and
- c. Envelope –III : Price Bid.
- The Bid must reach in the office of the undersigned within 30 (Thirty) days from the date of NIT in the Newspaper between on / before 15:00 hours.
- The technical bid of only those Bidders who meet the prescribed qualification criteria as mentioned above shall be evaluated.
- Envelope III: Price bids of only those bidders who are found to be techno-commercially responsive and qualified for the subject works shall be opened.
- Bids received late on account of any reason whatsoever and telegraphic / fax Bids & incomplete Bids will not be entertained.

2. O & M of Kanod Pump House
3. O & M of Akal Pump House
4. O & M of Sangrd Pump House
5. O & M of pipeline upto 50 km from IGNP canal at Mohangargh.
6. O & M of pipeline above 50 km to JSWBL plant, Bhadresh.

This order shall be finalised on single vendor only for all 6 packages on technically and commercially suitable vendor. Bifurcation or splitting of orders for different pump houses and pipe lines SHALL not be done

5) The Bid Security of 4 (Four) Lakhs INR in form of a Bank Guarantee must accompany the Bid. The validity of this BG shall be 180 days from the date of submission of the bid. Bids not accompanied by the Bid Security shall be rejected as non-responsive.

6) Bids shall be valid for a period of 180 days from the date of bid opening. For any further information on the Bid, the Bidders may contact the office of the undersigned.

7) Notwithstanding anything stated above, JSWBL reserves the right to assess the capabilities and capacity of the Bidder / his collaborators / associates / subsidiaries / group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Company.

8) Right to reject: JSWBL shall have the right to reject all or any Bid and shall not be bound to accept the lowest or any other Bid or to give any reason for such decision.
